Agenda Item no.4

The BDA Bhubaneswar has sought for clarification on the issues as detailed below.

- i) Whether constructions permitted and constructed before 2006 i.e. the date of notification of Ministry of Environment & Forest stipulating environmental clearance for construction having built up area more than 20,000 sq. meter would require environmental clearance as mentioned above while considering the regularization of construction in the year 2009 which are undertaken in deviation from the approved plan and unauthorisedly.
- ii) Whether permission is required for those constructions which were approved before 2006 and construction started before the issue of notification and completed after the date of notification.
