The 30th meeting of the State EIA Authority, Odisha was held on 03.07.2010 in the office chamber of the Chairman of SEIAA, Bhubaneswar at 4.00 PM. Dr. C.R Das, Chairman, SEIAA, chaired the meeting.

- 1) Minutes of the previous meeting was confirmed.
- i) The issuance of Environmental Clearance (EC) for building and construction project in favour of central Govt. employee's welfare housing organization Ministry of Urban Employment and poverty alleviation Govt. of India At-Begunia Barahi, Bhubaneswar, Odisha was discussed and decided to issue final Environmental Clearance in favour of the proponent as per recommendation of SEAC.
 - ii) As regards proposal for construction of group housing project "Vipul Garden" at Mauza-Shankarpur, Bhubaneswar of M/s Vipul Ltd. for issuance of Final Environmental Clearance in favour of the proponent was discussed. After discussion it was decided that the proponent would be requested again for a discussion to clarify on few expects like availability adequate ground water for drinking water supply as well as methodology of waste water treatment and its disposal. Accordingly the proponent will be requested to come with his technical person & architect for a discussion at the Authority.
